MEMORAN DUM OF ASSOCIATION

OF

THE RAMJAS FOUNDATION, DARYAGANJ, DELHI. (Registered under the Societies Registration Act XXI of 1860)

- I. The name of this association is the Ramjas Foundation, Delhi.
- The objects for which this association hereinafter referred to as 'the Foundation' is established are:-
 - 1. To provide School and University education for Boys and Girls.
 - 2. To maintain Schools, Colleges, Boarding Houses and Training
 Institutions for training of teachers.
 - To provide means for imparting Technical and Industrial education in connection with the Institutions under the control of the Foundation.
 - To provide means for imparting a sound moral and catholic religious education free from superstitions and controversial matters and based on the Vedas and ancient Shastras.
 - Sanskrit Literature and Philosophy of Amelent In Its
 - 6. To amalgamate with the Foundation any of the societies wing objects similar to those or any of these of the Foundation.
 - 7. To give loans to the Institutions aided, run, managed by or under the control of the Foundation and for the benefits of the students studying in the said Institutions, aid, grants, donations, subscribe to Government and/or Semi-Government Relief Funds, award Scholarships, Fellowships, Stipends of any kind as also to take, accept, donations, gifts and charities etc.
 - 8. To acquire or purchase properties, shares, debentures or other securities.

RULES AND REGULATIONS OF THE RAMJAS FOUNDATION, DELHI Preliminary.

1. In the following Rules and Regulations unless otherwise clearly stated the following words will have the meanings noted against each:

The 'Foundation' will mean the 'Ramjas Foundation, Dolhi'.

The 'Secretary' will mean the Secretary or Honorary Secretary of the Ramjas Foundation.

The 'Board' will mean the Board of Trustees of the Ramjas Foundation.

The Board of Trustees.

- 2. The Board will consist of individual members only who may be permanent or temporary and not less than 21 years of age, provided that the non-individual existing members of the Board will continue as members of the Board.
 - of the Board.

 (a) Temporary members of the Board will be those individual persons,

 who are recommended for the purpose by the Managing Committee

 of the Foundation and who agree to become members of the Board and

 who are elected in a General Meeting of the Board by a 2/3rd

 majority of the members of the Board prepart at the meeting, by

 virtue of their educational qualifications

 virtue of their educational qualifications

 exceptional devotion to the cause of education in general or of the

 Foundation in particular, likely to prove again to the Foundation.

 Such members will be temporary members and will be elected for a

 maximum period of three years at any one time and will be cligible

 for re-election at the expiry of his/her term. Number of such

 temporary members will not exceed 1/10th of the othes members

 subject to a maximum of five.
 - (b) Permanent members of the Board will consist of :
 - (i) all the existing members of the Board.
 - (ii) those individual persons who donate Rs.5,000/- or more to the Foundation and agree to become the members of the Board and

are elected in a General Meeting of the Board.

(iii) those individual persons who donate Rs. 25,000/-or more to the Foundation will be designated as Patrons of the Foundation, and will automatically become a permanent member of the Board unless he otherwise desires not to become a member of the Board.

Explanation:

For the removal of doubts, if any, it is clarified that 'donate', has the same meaning as 'gift' in section 122 of the Transfer of Property Act 1882.

- (c) Notwithstanding enything contained in clauses(ii) and (iii) the persons whose donations are accepted, shall be entitled to become members/Patrons of the Foundation or its Board only on their being elected so by a two-third majority at a General meeting of the board with not less than 75% members attending.
- 3. A member of the Board shall cease to be such in the following cases:
 - (a) In case of an individual if he dies or becomes of an unsound mind,
 - (b) If he resigns, from the date of acceptance of his resignation by the Board,
 - (c) If he fails to be personally present at six consecutive meetings of the Board, for reasons which are considered inadequate by a 2/3rd majority of the remaining members of the Board.
 - (d) If not less than 4/5th of the members are unanimous in considering that his continuance as a member of the Barrel is derimental to the true interests of the Foundation.
 - (e) If he is adjudicated an insolvent,
 - (f) If he is held guilty of any criminal offence involving moral turpitude.

General Meetings of the Board

4. The Ordinary General Meeting of the Board shall be held once in a Calendar year.

A thirty days notice shall be given to the members for the . Ordinary General Meeting.

5. All other General Meetings of the Board shall be called Special General Meetings.

- 6. At the Ordinary General Meeting the Board shall
 - (a) appoint by election from amongst its own members a Prosident, a

 Secretary and a Joint Secretary of the Board for the ensuing year, and
 shall also elect members of the Managing Committee in place of those
 retiring, who will be eligible for re-election.
 - (b) elect the Officer Bearers of the Managing Committee i.e. Chairman, Vice-Chairman, Secretary and Joint Secretary.
 - (c) appoint Auditor or Auditors for the ensuing Financial year.
 - and the Sub-Committees, as well as examine and consider Balance
 Sheets and the consolidated Budget of the Foundation and its
 Institutions.
 - (e) consider any other proposals or matters of importance of which due notice has been given in the Agenda.
 - 7. One fourth of members of the Board shall form a quorum.
 - 8. Whenever there is no quorum within half an hour after the time fixed for any General Meeting, it shall be adjourned to compatine (not later than the tenth subsequent day) and place, to be lixed the mambers present, of which at least three days notice shall be given the remaining members.

At such adjourned meeting, without regard to quorum the members present may at their discretion either proceed to the transaction of the business or adjourn the maeting as before to some other time or place, or dissolve it.

9. The Secretary, so far as possible with the previous consent of the President, may whenever he thinks fit, and shall, upon a requisition with a statement of object made in writing to that effect and signed by not less than seven members of the Board, convene a Special General meeting. Such special requisition with the statement of object shall be delivered personally to the Secretary or sent to him by post.

- 10. Any member of the Board desiring to bring forward any business at an Ordinary General Meeting must give not less than Twenty days' notice thereof to the Secretary who shall place the same before the Ordinary General Meeting.
 - The Chairman may with the consent of the members adjourn any General

 Meeting from time to time and from place to place, but no business shall

 be transacted at any such adjourned meeting other than the business left

 unfinished at the meeting at which adjournment took place.
 - 12. Every member of the Board shall have one vote only, but the Chairman shall have a second or casting vote in cases of equality of votes only.
 - 13. Notes of the proceedings of every General Meeting shall be recorded by the Secretary or in his absence by any other member of the Board who may be asked by the Chairman to do so and this record shall be signed both by the Writer of the Proceedings and the Chairman of the meeting.
 - 14. The Secretary, or in his absence the Joint Secretary shall arrange to forward without delay copies of resolutions passed at any General Meeting of the Board to the Sub-Committees, functionary or the individual concerned as the case may be.

Managing Committee and Sub-Committees

- 15. The management of various institutions of the Foundation shall subject to the general control of the Board, rest with a Managing Committee consisting of not less than Seven members and not more than Fifteen members who shall be elected in a General Meeting of the Board from amongst its own members.
- 16. The members shall hold office for three years, but may on the expiry of their term be re-elected.
- 17. One third of the members of the Managing Committee shall retire annually and shall be replaced by the members elected at the Annual General Meeting of the Board. Notwithstanding anything contained in rule 16

- 18. In case of a vacancy caused by regignation or death of otherwise among the members of the Managing Committee, the later may fill it by election from amongst the members of the Board for the rest of the term of the vacating member.
- 19. The Managing Committee may appoint one or more Sub-Committees for carrying on the management of the properties, assets and various institutions of the Foundation by election from amongst its own members or those of the Board.
- 20. The Managing Committee may appoint at its discretion any member of the tutorial staff or any other person for efficient management of y institution as a member of the Sub-Committee provided that the lumber of such members shall not exceed 1/3rd of the total strength of the Sub-Committee.

Powers and Duties of the Board, the Managing Committee & the Sub-Committees.

- 21. The Managing Committee shall have control over all the funds and other property of the Foundation subject to the general supervision of the Board, with the provisio that no immoveable property shall be transferred or leased out, for a period exceeding five years, without the consent of three-fourth majority of the members of the Board, present at the meeting of the Foundation specially called for the purpose.
- 22. The Managing Committee shall have power to borrow money, if necessary, from individuals, Banks or the Government for the purpose of the Foundation and to pay any rate of interest on it.

123. The power of appointment dismissal and acceptance of the resignation of the paid or honorary establishment of all the Instit tions of the Foundation shall rest with the Managing Committee, which may deligate its power trader this rule wholly or partially to a Sub-Committee or in case of the class IV employees even to the Head of any Institution.

Orders passed under this rule by a Sub-Committee or the Head of any Institution shall be subject to a right of appeal to the Managing Committee and all orders under this rule by the Managing Committee shall be subject to a right of appeal to the Board.

- 24. Rewards, increment in pay and other remunerations for good and meritorious work done by the paid staff of the Institution shall be passed by the Managing Committee within the sanctioned budget limit for the year on the basis of the recommendations made by the Sub-Committee or Head-of the Institution concerned.
- 25. Notes of proceedings of the meetings of the Managing Committee and of the Sub-Committees shall be taken and recorded at the time of the meeting.
- 26. Each sub-Committee shall prepare and subplict to the Managing Committee an Annual Budget for the ensuing year and the Managing Committee shall incorporate the same in its own Budget and lay it before the Ordinary General Meeting of the Board. The Annual Budget of any Sub-Committee may, if necessary, be revised by the Managing Committee at any time during the year provided that if the Consolidated Budget is likely to exceed its limit, special sanction of the Board shall have to be obtained.
- 27. The Managing Committee shall frame its own rules of business as well as those for the Sub-Committees, if any, from time to time subject to revision by the Board as provided hereafter under the following rules.

tevision of Rules and making of Bye-Laws.

d shall have power to revise the above Rule. and Regulations, we new ones from time to time as well as to make, re-peal or amend bye-laws for the conduct of the general affairs of the Institutions of the Foundation and for the despatch of business as it may be expedient provided that such bye-laws do not contravene any of the aims and objects set forth in the Memorandum of Association.

Notices.

29. Notices required to be given by the Board or by the Managing Committee or the Sub-Committee to their members may be given either personally or under Postal Certificates at their respective addresses registered with the Foundation
